Mesleğe başladığımda hiç kullanmadığım o bilgilerin, şu anda işimin çok büyük bir parçası haline gelmesindeki domino taşlarından biri de üniversite zamanında aldığım bu eğitim olmuştur.

Ticaretin globalleştiği, mesafelerin küçüldüğü ve sınırların yok olduğu mevcut iş dünyasında İngilizce'nin yerinin ne kadar önemli olduğunu anlatmama gerek yoktur sanırım. Yalnızca uluslararası işlerde değil ülke sınırları içerisinde bile bazı kurumsal firmaların iç yazışmalarında dahi İngilizce'yi kullandığını görüyoruz. Bir müvekkilinizin/müşterinizin sözleşmeleri, ülkenin önde gelen üniversitelerinden alınan raporlar, bankaların verdiği mektuplar, karşınıza çok büyük bir ihtimalle İngilizce olarak gelecektir. Hal böyle iken İngilizce'nin yanında mesleki İngilizce'ye de sahip olmanız rekabetin yüksek olduğu iş hayatında, sizleri diğer insanlardan bir gömlek daha üstün kılacaktır.

Hukukun yalnızca adliyelerden ve duruşmalardan ibaret olmadığını, iş dünyasının her alanında ve her aşamasında kuralların gerekli olduğunu unutmamak gerekir. Bu noktada sizlere tavsiyem, TOLES eğitimini almanız, kendinizi her daim geliştirmeye devam etmeniz ve hayatın sizlere açacağı kapılara, sunacağı fırsatlara karşı donanımlı bir şekilde hazır olmanız gerekmektedir.

TOLES DENEYIMLERIM

2014-2018 yıllarında Doğu Akdeniz Üniversitesi Hukuk Fakültesi'nde öğrenci oldum. Temel İngilizce derslerinden sonra, TOLES 1 dersini 2015 yılında aldım. Derslerin akıcı olması, sınavdan yüksek puanlar almam, konuları ve eğitmenleri sevmem gibi nedenlerle, tüm TOLES derslerini iki yılda bitirdim. Bu bilgi , benim sınava daha çok motive olmamamda etken olmuştur. Üniversitenin tanıtım birimi tarafından, sınav öncesi yapılan röportajla alacağımız sertifikanın meslek hayatımızdaki kazanımlarını değerlendirdik.

Bizimle yapılan bu röportajlar, daha sonra DAÜ tanıtım birimi tarafından yerel basına servis edilmiştir. Bu durum bizleri onurlandırmıştır.

TOLES DENEYIMLERIM

Ben Selin Faydalıtürk. 2016 ile 2020 yılları arasında Doğu Akdeniz Üniversitesi Hukuk Fakültesi'nde lisans eğitimimi tamamladım. Toles derslerini almaya ikinci sınıftan itibaren başladım ve son dönemime kadar onları devam ettirdim. Bu programın uzun vadede bana sağladığı en büyük faydalardan biri, kazandığım bilgiler sayesinde üniversite boyunca İngilizce ile bağımı hiç koparmamam oldu. I have been working as an intern at a law firm in Istanbul for approximately 8 months. If you were to ask what Legal English has done for me; firstly I have never regretted choosing Toles courses.
